### ORDER AMENDED

THIS APPLICATION made by BANKS DIH LIMITED and BANKS DIH HOLDINGS INC, was heard on the 9<sup>th</sup> day of July, 2024, at the High Court of the Supreme Court of Judicature, where the Applicant claims for the following orders inter alia

a) A declaration that the Guyana Securities Council ("GSC") created under the provisions of the Securities Industry Act Cap 73:04 (SIA) is a public body whose administrative acts or omissions are subject to the provisions of the Judicial Review Act Cap 3:06 ("JRA").

UPON READING the Fixed Date Application with Affidavit in Support, filed on the 20<sup>th</sup> December, 2023, Affidavit in Defence, filed on the 7<sup>th</sup> February, 2024, Submissions on behalf of the Applicants (introduction), filed on the 19<sup>th</sup> February, 2024, Submissions on behalf of the Applicants (preliminaries), filed on the 20<sup>th</sup> February, 2024, Submissions on behalf of the Respondent, filed on the 8<sup>th</sup> March, 2024, Supplementary Affidavit in Support of Terence Tyrrell, filed on the 18<sup>th</sup> March, 2024. AND UPON HEARING the submissions of the Attorney-at-law for the parties, AND the court having convened hearing based on letter of Mr. Boston SC; sent about an error in judgement and also seeking clarification on timelines.

# THIS COURT THEREFORE MAKES THE FOLLOWING FURTHER ORDERS:

1. That the Respondent shall give the Applicants at least 7 days' notice to provide all requested information in relation to the applications filed by the Applicants on 8<sup>th</sup> September 2023 which said notice shall be served on the Applicants no later than 16<sup>th</sup> July, 2024.

In the event that costs are not agreed, the Respondent shall file an application for costs to be assessed which application shall comply with Part 64:05 of the Civil Procedure Rules 2016.
